

Punchestown Stable Release of Liability

In consideration for being allowed to participate in handling of horses, mounting, riding lessons, jumping, boarding, training, showing and any and all other activities about the stable, riding ring, show ring, paddocks, fields, riding on the grounds of Punchestown Stable, or at any other location in conjunction with Punchestown Stable (hereinafter collectively "Horse- related Activities"), I for myself, my heirs, executors, administrators and assigns hereby waive and release **Sarah Meier** , her agents and employees, Punchestown Stable, its successors and assigns, related entities, agents, and employees (hereinafter collectively "**Punchestown**"), from any and all claims or causes of action for injury, damage or loss to my person or property, and/or that of my minor children, in any way arising or related to my participation and/or my minor child's participation in Horse-related activities with **Punchestown**, including claims or causes of action for injury, damage or loss to my person or property, and/or that of my minor children, in any way arising or related to my participation and/or my minor child's participation in Horse-related activities both on the property of **Punchestown** or on any other property where I and /or my minor child, might be engaged in such Horse- related activities with **Punchestown**, including claims or causes of action caused by my own acts and/ or the acts of my minor child, the acts of any horse or pony (whether owned by myself or **Punchestown** or a third party), or the acts of **Punchestown**, including acts of ordinary negligence, neglect or fault. I shall bring no claims, demands, actions or clauses of action, nor assist in the bringing or prosecution of any such claims and/ or litigation against **Punchestown** for any economic or no- economic losses including, but not limited to bodily injury, death, or property damage, sustained by me and/ or my minor child or legal ward.

I hereby represent and warrant that I have full knowledge of the risks and inherent risks of participating in this sport and Horse-related activities. I understand that horseback riding, jumping, and eventing are inherently dangerous activities and I accept that risk for myself and/ or my minor child. I agree to observe all safety rules and I represent that I am, and/ or my child is, physically fit and sufficiently prepared to participate in Horse-related activities.

I warrant and represent that I have provided **Punchestown** an accurate assessment of my knowledge and my ability, and/ or my minor child's knowledge and ability as it relates to Horse-related activities and I acknowledge that **Punchestown** shall rely on that information to assess the suitability of activities and mounts when establishing what Horse-related activities I or my child might take part in. I accept complete responsibility for the provision of inaccurate information that I provide **Punchestown**.
